Motion by Alderman Dorchinecz and seconded by Alderman Wilson to go out of closed session at 7:19pm. Motion carried 3-0.


Motion by Alderman Dorchinecz and seconded by Alderman Wilson to go into open session at 7:22pm. Motion carried 3-0.
