He has made several calls to the Police Department and only one Police Officer brought a sound decimal meter. The Backyard was asked to turn the music down by the Officer but as soon as he left, they turned it back up. They can no longer even enjoy their property.

Officer Nicols also addressed the Council in reference to the Police Officers taking home their vehicles. He advised rapid response is important and some Officers live just outside City limits. The Mayor advised that if they would like this to be revisited next City Council meeting, they should speak with the Aldermen to see if anyone would be willing to change their vote.

Motion by Alderman Bryant and seconded by Alderman Skultety to adjourn. The Mayor announced the motion carried 8-0.
