Ordinance - Approving and Authorizing the Execution of the First Amendment to the Business District Agreement by and between the City of Taylorville and Christian County Young Men's Christian Association, Inc. (900 McAdam Drive).

Ordinance – To Authorize Purchase of Personal Property (re: 2026 John Deere X750 garden tractor and 2026 John Deere 54D deck with mulch control kit).

Ordinance – City of Taylorville, Christian County Illinois, proposing the incurring of a loan and issuance of waterworks revenue bonds of the City in aggregate principal amount not to exceed \$18,000,000.00 for the purpose of defraying the cost of acquiring and constructing improvement to the waterworks system of the City.

Resolution – Authorizing the Mayor to sign the loan application document for the Lead Service Line Replacement Funding.

Motion to ratify and approve the Contract Documents for the Rehabilitate Hangar Roof project at the Taylorville Airport, known as Illinois Project TAZ-5192; and to approve the low bid proposal of Right Way Traffic Control for \$200,550.00 and direct the Mayor to issue the applicable Notice of Award to such bidder.

Motion to authorize and direct the Airport Manager to request a Program Letter from IDOT for the Airport Layout Plan (ALP) Update Project. A proposed draft Agreement with CMT will be provided at a later date using the Standard Agreement for Architectural/Engineering, Planning, and Special Services, Authorized for use by IDOT, subject to the review and approval of the City Attorney.

Motion to Authorize the Mayor to sign the joint funding agreement with the State of Illinois Department of Transportation in reference to the Downtown Rehabilitation.

Motion to Recommend to the City Council to establish a Business License and software implementation, with an annual fee of \$100.00.
