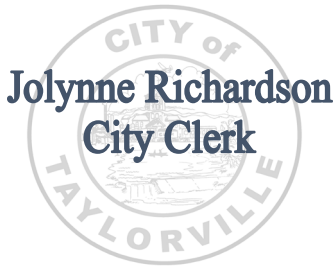

There will be a meeting of the Cemetery Board of Managers on Tuesday, March 11, 2025 starting at **5:30 P.M.** in the **Conference Room** of the Municipal Building, 115 North Main, Taylorville, Illinois.

The purpose of the meeting is for discussion and consideration in whole or in part of the following subject matters and/or motions to approve/deny/reject/ review/table/amend:

1. Purchasing a Trailer with perpetual care interest funds, at a cost not to exceed \$3,500.00. The current trailer will be sold at auction with the funds to be placed back into the perpetual care interest fund.
 2. Replacement of Leaf Vac with perpetual care interest funds, at a cost not to exceed \$3,125.00 The current Leaf Vac will be sold at auction with the funds to be placed back into the perpetual care interest fund.
 3. Salt Spreader for the F-350 Dump Truck with perpetual care interest funds, at a cost not to exceed \$6,000.00.
 4. To approve \$10,000.00 of the perpetual care interest funds to go towards a Columbarium, with the City paying the additional \$70,000.00. Fifteen percent of all Niche sales will be placed into the perpetual care fund.
 5. Review and Approve the 2025/2026 Budget.

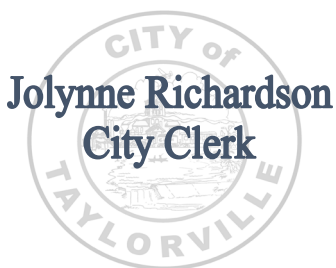
