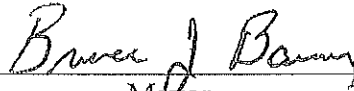


At the regular meeting held in the Council Chambers by the City Council, January 6, 2025, the following proceedings were held and entered in this record in the following words and figures to wit:

The Invocation was given by Mayor Barry. Mayor Barry led the Council and assembled the group in the Pledge of Allegiance.

Roll Call - Aldermen Brown, Bryant, Dorchinecz, Driskell, Mitchelson, Olive, Skultety, and Wilson were present.

APPROVAL OF MINUTES

Motion by Alderman Bryant and seconded by Alderman Brown to utilize the Omnibus Vote Designation for Various Meetings as listed below. Roll Call - Aldermen Brown, Bryant, Dorchinecz, Driskell, Mitchelson, Olive, Skultety and Wilson voted YEA. The Mayor announced the motion carried 8-0.

Motion by Alderman Dorchinecz and seconded by Alderman Bryant to approve Regular City Council Meeting held December 16, 2024, the Emergency Services Meeting held January 2, 2025 and the Personnel Committee Meeting held January 2, 2025. Roll Call - Aldermen Brown, Bryant, Dorchinecz, Driskell, Mitchelson, Olive, Skultety and Wilson voted YEA. The Mayor announced the motion carried 8-0.

PLAN COMMISSION RECOMMENDATION

Pat Kretzer advised the City Council that the Plan Commission voted to deny changing the Ordinance Amending Section 10-8-3 of the Taylorville City Code (re: off street parking requirements for taverns and bars).

Motion by Alderman Bryant and seconded by Alderman Skultety to Approve and Amend Section 10-8-3 of the Taylorville City Code (re: off street parking requirements for taverns and bars). Roll Call - Aldermen Brown, Bryant, Dorchinecz, Driskell, Skultety, and Wilson voted YEA. Aldermen Mitchelson, Olive and Mayor Barry voted NAY. The Mayor announced the motion carried 6-3.
