## MANNER'S PARK POOL PRESENTATION

Bailey Hancock, Director of the Taylorville Park District, presented the proposed plans for the new pool at Manner's Park. The current park pool was built in 1962 with updates and repairs over the years. It is beyond repair in certain areas. The anticipated cost of the new pool is \$7.2-7.8 million, and will include a splash pad, zero entry pool and the large pool with 25' and 50' lanes for swim meets. There is a referendum on the April 4, 2023 ballot to raise \$6.5 million, which is the maximum amount eligible. If the referendum passes, the remainder will be raised by fundraisers and grants if available. She encouraged the support of the Council and entire community, as the pool provides a place for children and adults to gather.

BUSINESS FROM THE PUBLIC

The Mayor asked if anyone wished to address the Council. Derek McConnell, AFSCME Union President, discussed the Union's objection to the new Dress Code Policy for City office employees, stating that the Union should have been approached prior to adoption of the policy, and a Labor Relations meeting held to seek input and bargaining from the Union. He is claiming discrimination by the adoption and enforcement of this policy, and demanded that the Council rescind the policy immediately. Kayleigh Boston stated that as a Dispatcher, she felt this was discriminatory and believes that each department should be allowed the opportunity to set their own policy. She has a petition signed by many employees of the City and of other local businesses in support of rescinding the dress code policy. Damon Moore informed the Council that his grandfather, a former Superintendent and Alderman, was covered in tattoos, and he also felt this policy was discriminatory. Crystal Nichols spoke in favor of the employer's right to set such a policy and that it should be followed by the employees; she stated that not all Union employees have an issue with the policy. Josh Nicol is a member of the AFSME Union Executive Board and would like to see discussion opened up between the Union and the Council in regular Labor Relations Meetings.

Motion by Alderman Bryant and seconded by Alderman Skultety to adjourn the meeting. Motion carried (7-0).

The meeting adjourned at 7:52 P.M.
