At the Special Council Meeting held in the Council Chambers by the City Council, May 10, 2021 the following proceedings were held and entered in this record in the following words and figures to wit:

The Mayor called the meeting to order at 6:00 P.M.

Roll Call - Aldermen Brown, Bryant, Budd, Dorchinecz, Olive, Skultety, and Wilson reported present. Alderman Driskell was absent.

Also present in the Council Chambers were Mayor Barry, City Attorney Romano, Clerk Lilly, Superintendent Speagle, and Human Resource Manager Conrath.

VACANCY IN OFFICE OF CITY TREASURER

Motion by Alderman Bryant and seconded by Alderman Brown to go into Closed Session pursuant to 5 ILCS 120/2 (c)(1) and (c)(3) to discuss the vacancy in the Office of City Treasurer, to create the Office of Deputy Treasurer, and discuss the impending vacancy in the Office of Deputy Clerk, and the appointment of and/or bidding and/or advertisement for persons to such Offices, and related employment and compensation for such appointed Officers, and any and all subject matters relating thereto; and to include, if present, the following persons to be present during all or part of such closed session, namely: the Mayor, Aldermen, City Attorney, City Clerk, Human Resource Manager, Water Superintendent Speagle, and such other person or persons as the Mayor may decide and announce during this Special City Council meeting and/or during such closed session.

The City Council recessed at 6:02 P.M. and went into Closed Session at 6:02 P.M. Alderman Driskell reported present at 6:12 P.M. The City Council returned to Open Session at 6:20 P.M.

Roll Call - Aldermen Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson reported present.

Motion by Alderman Bryant and seconded by Alderman Wilson to approve the Mayor's two-year appointment of Kellie Hamell as City Treasurer at a base salary of \$50,000.00 with a 2% increase in year one for an annual salary of \$51,000.00 and 2% increase in year two for an annual salary of \$52,020.00, per Ordinance No. 3992, due to the abandonment of Treasurer-elect Alberssen. Roll Call - Aldermen Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson voted YEA. The Mayor announced the motion carried.

Motion by Alderman Bryant and seconded by Alderman Skultety to retain Kellie Hamell as the Water Billing Office Manager at a reduced salary of \$6,000.00 per year. Roll Call - Aldermen Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson voted YEA. The Mayor announced the motion carried.

Motion by Alderman Bryant and seconded by Alderman Skultety to adjourn. Motion carried (8-0).

The meeting adjourned at 6:23 P.M.
