APPROVAL OF MINUTES

Motion by Alderman Bryant and seconded by Alderman Olive to utilize the Omnibus Vote Designation to approve the minutes of various meetings. Roll Call - Aldermen Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson voted YEA. The Mayor announced the motion carried.

Motion by Alderman Driskell and seconded by Alderman Wilson to approve the minutes of the Regular Meeting held May 3, 2021; the Band Committee Meeting held May 4, 2021; the Emergency Services Committee Meeting held May 6, 2021; the Personnel Committee Meeting held May 6, 2021; the Special City Council Meeting held May 10, 2021; the Water/Environmental Committee Meeting held May 13, 2021; and the Lake/Airport Committee Meeting held May 13, 2021. OMNIBUS VOTE.

RESOLUTION NO. 1467 - RELATING TO PARTICIPATION BY ELECTED OFFICIALS IN THE ILLINOIS MUNICIPAL RETIREMENT FUND

Motion by Alderman Budd and seconded by Alderman Brown to approve Resolution No. 1467 -Relating to Participation by Elected Officials in the Illinois Municipal Retirement Fund. This Resolution allows for newly elected Aldermen to participate in IMRF should their yearly hours of service be 1,000 or greater. Roll Call - Aldermen Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson voted YEA. The Mayor announced the motion carried.

EAST MAIN CROSS STREET IMPROVEMENTS - BENTON & ASSOCIATES PROPOSAL

PURCHASE ASCO SERIES 300 AUTOMATIC TRANSFER SWITCH - ALTORFER POWER SYSTEMS

Motion by Alderman Bryant and seconded by Alderman Olive to purchase an ASCO Series 30 automatic transfer switch from Altorfer Power Systems for a cost of \$3,266.00 plus installation. 2021 EMPLOYEE HANDBOOK UPDATES

HIRING OF TERRI FRANCE, INDEPENDENT CONTRACTOR

Motion by Alderman Budd and seconded by Alderman Driskell to approve the letter to hire Terri France as an Independent Contractor at a rate of \$35.00 per hour for training of City Treasurer Kellie Hamell. Discussion was held regarding the parameters of this agreement to include a maximum of 600 hours per year; Ms. France can be utilized until no longer needed or until either she or the Mayor decide to terminate this agreement. MAYOR PRO TEM

Motion by Alderman Olive and seconded by Alderman Wilson to name Alderman Larry Budd as Mayor Pro Tem in the absence of Mayor Barry. Roll Call - Alderman Brown, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson voted YEA. Alderman Bryant abstained. The Mayor announced the motion carried.

RESIGNATION OF WATER OFFICE MANAGER HAMELL/RESCIND SALARY MOTION

Motion by Alderman Driskell and seconded by Alderman Skultety, per advice of the City Attorney, to accept the resignation of Kellie Hamell as the Water Office Manager and to rescind the Motion adopted at the May 10, 2021 Special City Council Meeting that approved her remaining in the office of Water Office Manager at a reduced salary of \$6,000.00. A City Treasurer cannot be paid another salary, or hold another position/office per State Statute under the Appropriations system of operations. Roll Call - Aldermen Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson voted YEA. The Mayor announced the motion carried.

ORDINANCE NO. 4038 - AN ORDINANCE APPROVING AN AMENDMENT TO ADD TERRITORY TO THE TAYORVILLE-CHRISTIAN COUNTY ENTERPRISE ZONE AND TO AMEND THE INTERGOVERNMENTAL COOPERATION RELATING TO SAID ENTERPRISE ZONE

Motion by Alderman Budd and seconded by Alderman Bryant to adopt Ordinance No. 4038 - An Ordinance Approving an Amendment to Add Territory to the Taylorville-Christian County Enterprise Zone and to Amend the Intergovernmental Cooperation Agreement Relating to said Enterprise Zone. HIRE ONE POLICE OFFICER - LATERAL HIRING

Motion by Alderman Driskell and seconded by Alderman to hire one(1) Police Officer through the lateral hiring list in the Police Department. Roll Call - Alderman Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson voted YEA. The Mayor announced the motion carried.

WATER/ENVIRONMENTAL

PURCHASE OF TWO COMPUTERS - WATER COLLECTION OFFICE - CTI

Motion by Alderman Bryant and seconded by Alderman Wilson to approve the purchase of two(2) computers and monitors for the Water Collection Office from CTI at a cost not to exceed \$2,881.52. Roll Call - Aldermen Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson voted YEA. The Mayor announced the motion carried.

PURCHASE OF ANIONIC PUMP - HYDRO-KNETICS

Motion by Alderman Bryant and seconded by Alderman Brown to approve the purchase of an Anionic Pump from Hydro-Knetics at a cost not to exceed \$5,840.00 plus freight. Roll Call - Alderman Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson voted YEA. The Mayor announced the motion carried.

LAKE/AIRPORT

PURCHASE OF EXMARK LAZER Z DIESEL MOWER - AIRPORT FUEL ACCOUNT

Motion by Alderman Budd and seconded by Alderman Bryant to approve the purchase of a new Exmark Lazer 2 Diesel, 25 HP Yanamar, with a five-year warranty at a cost not to exceed \$17,359.00, with the money coming from the Airport Fuel account. Roll Call - Alderman Brown,

10% PAY INCREASE - HBO GOODALL

Motion by Alderman Budd to approve an increase in pay of 10% of HBO Goodall's current salary as compensation for the extra duties he is performing at the Airport. Motion by Alderman Driskell and seconded by Alderman Brown to table. The City Code lists a specific procedure to be followed for Superintendent increase to include an evaluation performed by the Mayor and Personnel Committee to include a rating scale from 0-6%. Personnel Committee Chairman Driskell would like to see this taken to the Personnel Committee for further review and discussion, to include Superintendent Job Descriptions, Evaluation Forms and Salary Increases. Roll Call - Aldermen Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson voted YEA. The Mayor announced the motion to table carried.

PAYMENT OF BILLS

Motion by Alderman Budd and seconded by Alderman Dorchinecz to approve payment of bills. Roll Call - Alderman Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson voted YEA. The Mayor announced the motion carried.

BUSINESS FROM THE PUBLIC

Mayor Barry asked if any member of the public desired to speak to the Council. Terri France addressed the Council to congratulate Kellie Hamell on her appointment to the position of City Treasurer. She also stated that she wished to show her appreciation on behalf of the City to Former Treasurer Jacque Nation for continuing to assist the City in finishing out the month end, Fiscal year-end, and preparation of documents for the Fiscal year-end Audit. She has accepted a full-time position with the State of Illinois so she is completing this work on her own time, after hours, with no pay from the City. Ms. France went on to say she is happy to assist in the training of Treasurer Hamell until her services are no longer needed.

CLOSED SESSION

Motion by Alderman Bryant and seconded by Alderman Brown to go into closed session, pursuant to 5 ILCS 120/2 (c) (11) to discuss the pending litigation, i.e. "Jamal Shehadeh v. City of Taylorville, Cause No. 2021-MR-21, Circuit Court 4th Judicial Circuit, Taylorville, Illinois; and the two Interlocutory Appeals filed by Jamal Shehadeh with the 5th District Appellate Court in General Nos. 5-21-0105 and 5-21-0128" and any and all subject matters relating thereto including, but not limited to, subject matters relating to investigation, attorney-client reports, consultant reports, discovery, settlement negotiation, offers, issues and strategy, and to include the following persons to be present during all or part of such closed session, namely: the Mayor, Aldermen, City Clerk, City Treasurer, City Attorney, Police Chief, and such other person or persons as the Mayor may decide during this City Council meeting and/or during such closed session.

The City Council recessed at 7:29 P.M. and went into Closed Session at 7:35 P.M. The City Council returned to Open Session at 8:06 P.M.

Roll Call - Aldermen Brown, Bryant, Budd, Dorchinecz, Driskell, Olive, Skultety, and Wilson reported present.

Motion by Alderman Bryant and seconded by Alderman Olive to adjourn the meeting. Motion carried (8-0).
