Once the Common Street Maintenance Account reaches a balance of \$300,000.00, any money distributed to the Street Maintenance Fund will be divided 4 ways, equally amongst the 4 Wards with the Committee to recommend to the City Council for approval for the 1/5 division of the Commons Street Maintenance Account portion. CITY CODE TITLE 3 SECTION 2-4 - MUNICIPAL UTILITY TAX MONEY PROCEDURE

Motion by Alderman Jones and seconded by Alderman Dorchinecz to direct the City Attorney to amend the Taylorville City Code to incorporate into Title 3 Section 2-4 the Municipal

Utility Tax Money Procedure as presented with the following amendment to #3: The Street Maintenance Fund represents the total amount of monies that is divided 5 ways equally: One-fifth(1/5) to each Ward and one-fifth(1/5) to a Common Street Maintenance Account. Roll Call - Aldermen Budd, Burtle, Dorchinecz, Jones, Lanzotti, Olive, Vota, and Walters voted YEA. The Mayor announced the motion carried.

CHRISTIAN COUNTY SENIOR CITIZENS DONATION

ENTERPRISE ZONE AGREEMENT

Motion by Alderman Budd and seconded by Alderman Walters to enter into an Agreement with the firm represented by Mr. Doug McDermith, as suggested by Ms. Mary Renner, based upon a clarification of item #2 of the Agreement and present to the City Attorney for review(in regards to the Enterprise Zone), once clarification is received. The current Enterprise Zone expires in 2021; business participants will be asked to contribute to the costs of the new agreement. It is estimated to cost between \$60,000.00 - \$100,000.00. Alderman Walters informed the Council that he and Superintendent Wiseman had met with IDOT regarding the Walnut Street Project. Truman Flatt was awarded the bid. The project will run from Pleasant Street to Adams Street on Walnut and will involve road and intersection closings at times.

Alderman Burtle requested that Alderman Budd address the shortfalls in City finances at the next Finance Committee Meeting. Alderman Budd thanked all those who have supported the projects in the TIF Districts as we move forward with the business expansion in that area.

Motion by Alderman Jones and seconded by Alderman Vota to adjourn. Motion carried (8-0).
