Each reservation must be accompanied by the first night's camping fee; this is a non-refundable reservation fee that will be applied to your first night's stay. Beginning April 1, 2024, it will be required that a credit card be kept on file with the Marina Office in case of any damages to Lake Taylorville property. Please make checks payable to the City of Taylorville. If your application does not include the correct fee, your check will be returned to you. Reservations will be taken by phone or in person beginning on the first day the marina opens for the season, April 1 of each year. Reservations are not final until written confirmation is provided by the City of Taylorville.

No reservations will be accepted for longer than seven (7) consecutive nights. Cabins #1, #2, #3 and #4 are available to rent from April 1st through October 31st of each year. For a reservation to be added to the Reservation List, this form will need to be filled out, signed, and returned to the Marina Office, ALONG with the non-refundable first night's stay fee.

The rent for a cabin Sunday through Thursday is \$70.00 per night. Friday, Saturday, and Holidays are \$75.00 per night. The fee required to reserve a cabin, for each cabin, will be the correct first night's cabin rental fee, this is a non-refundable reservation fee that will be applied to your first night's stay. These fees must be confirmed by the City of Taylorville before the reservation is final. The balance MUST be paid in full upon arrival. For Memorial Day, Independence Day and Labor Day Holiday weekends, a reservation must be made for a minimum of two (2) consecutive nights.

These are one (1) room cabins with shower/restroom. Campers must bring their own bed linen and personal items. The City of Taylorville will not be held responsible for any personal items left behind.

Shower house/bathrooms are at the Marina. Swimming is allowed ONLY at the beach in the designated area, during season (Memorial Day through Labor Day). Hours are posted. NO LIFE GUARDS ON DUTY. Please do not leave children unattended at the beach, restrooms, or the Marina. Pets MUST be kept on a leash and NOT allowed on the beach.

Deposit/Cancellation Policy:

If a reservation is cancelled two (2) days before the arrival date, the cancelling party will receive any additional rent that has been paid for their stay. If a reservation is cancelled less than two (2) days before the arrival date, the cancelling party forfeits any amount they have paid for their stay.

Holiday weekend cancellations will forfeit any additional rent paid for the stay unless cancelled seven (7) days prior to the holiday weekend.

No refunds for early departure. "Quiet hours" are 11:00pm to 6:00am.

Lake Superintendent reserves the right to remove any person(s) for violation of any lake rules.

Any damage to cabin property, whether accidental or willful, is the responsibility of the registered guest. Any costs associated with repairs and/or replacement will be charged to the registered guest. In extreme cases, criminal charges will be pursued. Failure to return key cards for Cabins will result in a \$25 fee. Failure to pay said fee will result in the reserving persons being prohibited from staying at the Lake in the future.
