BUSINESS FROM THE PUBLIC

Mayor Barry asked if any member of the public desired to speak to the Council. Chief Crews updated the Council on the status of the recent tornado. There were (2) tornadoes that touched the City with windspeeds of 155 mph and a classification of F3. The tornado that hit Taylorville was ½ mile wide. The progression from life safety to stabilization is now under way. A team consisting of City, County and State Disaster agencies have formed and will be in town until the need diminishes. There have been over 500 homes with damage and 15 businesses as of today. Teams are still out assessing all affected areas. There will be a Multi-Agency Resource Center set up later in the week to help the victims. Ameren is making great strides in returning power to all, with 200 open tickets at this time.
