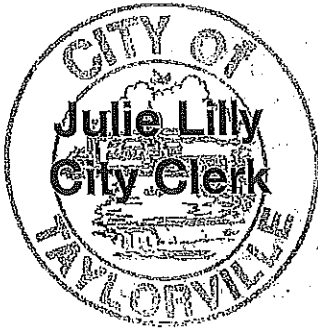

**5-3A-10: PENALTIES:**

Any person violating any provisions of this article shall, upon conviction thereof, be fined in accordance with the following schedule:

First offense	\$ 75.00
Second similar offense	100.00
Third similar offense	125.00
Fourth similar offense and each similar offense thereafter	A sum not less than \$125.00 nor more than \$750.00

A separate violation shall be deemed committed on each day which a violation for the same offense occurs or continues.

The police officer or animal control officer may issue citations for violations of this article. Any person issued a citation for a first, second, or third offense pursuant to this article may pay the amount of the aforesaid designated penalty for such offense at the city clerk's office within ten (10) days from the date of such citation. If not so paid within such ten (10) days, then an ordinance violation complaint shall be filed with the appropriate court. (Ord. 3535, 10-3-2011)

**5-3A-11: PROHIBITED ANIMALS:**

It is unlawful to harbor, keep, or permit to be kept or harbored any poultry, cattle, swine, sheep, goats, horses, or similar animals within the city corporate limits.

Exceptions:

- A. The above listed animals may be allowed on property zoned AG-1 or AG-2 within the corporate city limits.
- B. The above named animals may be allowed on property within the city corporate limits used for zoological parks, animal exhibitions, educational institutions, veterinarian hospitals, animal shelters, or pounds.

Any person violating this section shall be subject to the penalties noted in section 5-3A-10 of this article. (Ord. 3535, 10-3-2011)

**7-5-1: RUNNING AT LARGE PROHIBITED; IMPOUNDMENT AND DISPOSAL:**

No person shall cause or permit any domestic livestock or poultry to run at large in the Lake Taylorville area. Any livestock or poultry or any domestic animals found at large may be taken by the city and sold to pay the cost and expense of taking, keeping, advertising and selling such livestock or poultry and all damage caused to the city or its property by such livestock or poultry. Any such livestock or poultry found at large and which are not easily apprehended by city employees or agents may be, at the discretion of the city, removable even by destruction of the same. (Ord. 1918, 7-16-1979)

**5-3-1: LIVESTOCK:**

A. Running at Large Prohibited; Impoundment and Redemption: It shall be unlawful to permit any cattle, horse, swine, sheep, goats or poultry to run at large in the City. Any such animal running at large in any public place in the City shall be impounded in the manner provided for dogs in this Chapter. 2 (1979 Code Ch. 17, Art. I, §4)

The owner of any impounded animal may redeem it from the pound upon payment of the fee as provided in subsection 5-3A-4C of his Chapter for dogs. (1979 Code Ch. 17, Art. I, §5)

B. Tying for Grazing: It shall be unlawful to picket or tie any animal enumerated in subsection A of this Section in the streets of the City for the purpose of grazing or feeding. (1979 Code Ch. 17, Art. I, §4)
