PERSONNEL COMMITTEE

BID AND/OR ADVERTISE PLANT OPERATOR POSITION AT THE WATER PLANT

Motion by Alderman Vota and seconded by Alderman Burtle to allow Water Superintendent, Dave Speagle to bid and/or advertise the Plant Operator Position at the Water Plant. Roll Call - Aldermen Budd, Burtle, Dorchinecz, Jones, Lanzotti, Olive, Vota, and Walters voted YEA. The Mayor announced the motion carried.

EMERGENCY SERVICES COMMITTEE

AMEND TITLE 3 CHAPTER 6 OF THE TAYLORVILLE CITY CODE REGARDING NICOTINE PRODUCTS

Motion by Alderman Dorchinecz and seconded by Alderman Burtle to direct the City Attorney to amend Title 3, Chapter 6 of the Taylorville City Code to include the language to mirror the Illinois State Statutes regarding the distribution and possession of alternative nicotine products to persons under 18 years of age. Motion carried (8-0).

POLICE DEPARTMENT - PURCHASE WI-FI ACCESSIBILITY EQUIPMENT

Motion by Alderman Dorchinecz and seconded by Alderman Burtle to allow Police Chief Hile to obtain Wi-Fi accessibility from Computer Techniques, Inc. for the Police Department at a cost not to exceed \$1,400.00. Roll Call - Aldermen Budd, Burtle, Dorchinecz, Jones, Lanzotti, Olive, Vota, and Walters voted YEA. The Mayor announced the motion carried.

POLICE DEPARTMENT - PURCHASE 3 ARMOR EXPRESS RAZOR GEN II BODY ARMORS

Motion by Alderman Dorchinecz and seconded by Alderman Walters to allow Police Chief Hile to purchase 3 Armor Express Razor Gen II Body Armors at a cost of \$795.00 each for a total of \$2,385.00 from Ray O'Herron, Inc. with \$1,192.50 coming from the Bulletproof Vest Partnership Grant. Roll Call - Aldermen Budd, Burtle, Dorchinecz, Jones, Lanzotti, Olive, Vota, and Walters voted YEA. The Mayor announced the motion carried.

PAYMENT OF BILLS
