ORDINANCE NO. 3973 - AN ORDINANCE APPROVING AND AUTHORIZING THE EXECUTION OF A BUSINESS DEVELOPMENT DISTRICT NO. 1 REDEVELOPMENT AGREEMENT BY AND BETWEEN CITY OF TAYLORVILLE, ILLINOIS AND JOHN MCDOWELL (DBA ANGELO'S PIZZA)

Motion by Alderman Budd and seconded by Alderman Driskell to approve Ordinance No. 3973 - An Ordinance Approving and Authorizing the Execution of a Business Development District No. 1 Redevelopment Agreement by and between City of Taylorville, Illinois and John McDowell (dba Angelo's Pizza). Roll Call - Aldermen Bryant, Budd, Burtle, Dorchinecz, Driskell, Lanzotti, Olive, and Mayor Barry voted YEA. Alderman Skultety voted NAY. The Mayor announced the motion carried.

RESOLUTION NO. 1450 - AUTHORIZING EXECUTION OF EASEMENT AGREEMENTS AND ACKNOWLEDGE AND CONSENT AGREEMENTS

Motion by Alderman Skultety and seconded by Alderman Olive to approve Resolution No. 1450 -Authorizing Execution of Easement Agreements and Acknowledge and Consent Agreements. City Attorney Romano noted that the Park District has not approved as of yet, nor has the Christian County Fair Board, for the easements. This resolution allows for modifications to be made to the agreements as necessary. Roll Call - Aldermen Bryant, Budd, Burtle, Dorchinecz, Driskell, Lanzotti, Olive, and Skultety voted YEA. The Mayor announced the motion carried.

BDD LEASE/MORTGAGE GRANT PROGRAM APPLICATIONS

Motion by Alderman Bryant and seconded by Alderman Budd to approve the total payment of \$39,380.04, with Lease Grant Applications totaling \$29,780.00 and Mortgage Grant Applications totaling \$9,600.04. Roll Call - Aldermen Bryant, Budd, Burtle, Dorchinecz, Driskell, Lanzotti, and Olive voted YEA. Alderman Skultety voted NAY. The Mayor announced the motion carried.

UTV PERMITS

Mayor Barry noted that he would like to see the number of UTV permits increased. The limit is now 35 and all are issued. He has received several calls to increase the availability. Initially there was a six month trial period for these permits, capped at 25, then subsequently increased to 35. Several Aldermen voiced concerns stating that the trial period has not passed and this would be the second increase made. Discussion was held regarding the design and placement of stickers for visibility, along with a consensus that the Ordinance should be revisited in October to reevaluate the requirements and details. Motion by Alderman Bryant and seconded by Alderman Dorchinecz to remove the limits on UTV permits through the original six month trial period and direct the City Attorney to prepare an Ordinance to amend the City Code to address this modification. Roll Call - Aldermen Bryant, Dorchinecz, Lanzotti, Olive, and Skultety voted YEA. Aldermen Budd, Burtle, and Driskell voted NAY. The Mayor announced the motion carried.

VOLLENTINES ADDITION WARD III STORM SEWER PROJECT - ENTLER EXCAVATING CO., INC. Motion by Alderman Dorchinecz and seconded by Alderman Bryant to pay Entler Excavating Co., Inc. in the amount of \$80,037.00 for work performed on the Vollentines Addition Ward III Storm Sewer Project, Contractor's Pay Request #1, this conditioned upon receipt of signed mechanics lien waivers in this amount and recommendation by the Project Engineer that the work has been satisfactorily performed. This has been approved by Greene and Bradford for payment; awaiting lien waiver to issue payment. Roll Call- Aldermen Bryant, Budd, Burtle, Dorchinecz, Driskell, Lanzotti, Olive, and Skultety voted YEA. The Mayor announced the motion carried.

AWARD BIDS FOR SALE OF FIRE VEHICLES

Motion by Alderman Skultety and seconded by Alderman Olive to accept the high bid of \$6,100.00 for the 2000 Jeep Cherokee. Roll Call - Aldermen Bryant, Budd, Burtle, Dorchinecz, Driskell, Lanzotti, Olive, and Skultety voted YEA. The Mayor announced the motion carried.

The Mayor announced the motion carried.

HEAVY EQUIPMENT OPERATOR B - STREET DEPARTMENT
