## SCHOOL RESOURCE OFFICER REIMBURSEMENT

Mayor Barry noted that this is a 33% increase in reimbursement and will include a portion of salary plus compensation of benefits for this officer. # PAYMENT ON 2018 POLICE INTERCEPTOR LOANS

Motion by Alderman Budd and seconded by Alderman Driskell to utilize funds for the Totaled police vehicles to make a final payment on the loan for the 2018 Ford Police Interceptor in the amount of \$20,956.29 plus \$1.35 interest per day and make an additional payment on the
