## Superintendent Airport Report

May 14, 2020

### New Credit Card Reader

I'm coordinating the installation of the M4000. Weather permitting, installation will be in May. Waiting for better weather to install new credit card reader.

### Airport Block Grant

Taylorville Airport has qualified for a \$30,000 100% grant. I'm working on lining up apps and Agreements. Treasurer Nation is working on the ICQ (Internal Control Questionnaire) for fiscal year 2021. This grant can be spent on wages, insurance, Maintenance, Supplies almost anything.

### Economic Impact Study

IDA is conducting an economic impact study. The last one was done in 2011. I'm to receive forms and questionnaires. Meeting with them on 5-26-20.

### Taxiway Maintenance Project

The first phase of the 1.5 million maintenance rehabbing of the taxiway (south half), new LED lighting, installing a new rotating beacon on city property, and our cost approximately is \$70,000. I'm in the process of talking to IDA about getting our local cost lowered to \$15,000 to \$30,000.

### Solar Energy Production

The month of **March & April** produced **4250.1 KWH**. This is approximately **\$637.67** in electricity cost savings to the city. To date the solar panels has produced **198,721.1 KWH** of electricity. This has save the City approximately **\$29,808.16** in electricity cost.

### What has happen at the Airport?

- Regulator/Transformer for the East/West runway is over loading.
- Replaced battery in courtesy car on 2-13-20
- Security light was replaced with a LED light on 2-17-20
- 8200 gallons of Avgas was delivered on 3-6-20
- Waiting for north and south hangar roof estimates
- Waiting for runway re-stripping estimates
- Purchased 7500 gallons of Jet -A on 4-6-20

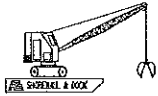
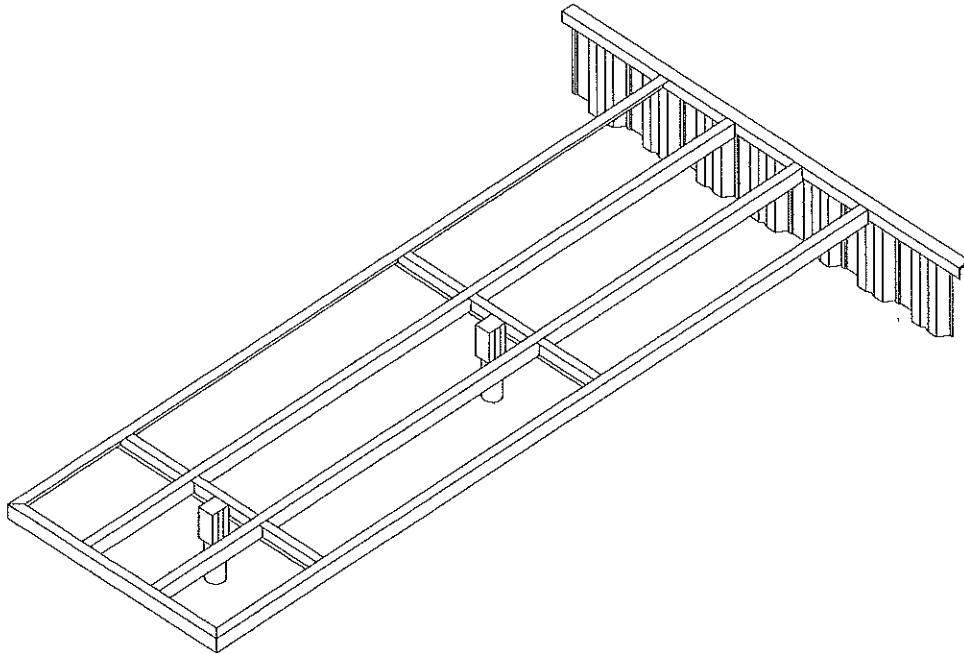
