#### BUSINESS FROM THE PUBLIC

Mr. Pat Kretzer addressed the Council regarding an Ordinance that had passed through the Committee (3-0) and the Council (6-0) regarding a No Parking Sign in the 400 Block of West Poplar on the South side of the street. This is in direct relation to a property that Mr. Kretzer owns, and the blocking of his ability to exit the driveway safely. He is questioning why the sign has not been put in place. Mayor Barry stated that he felt people were not properly notified of this and he instructed Superintendent Wiseman to not install the signs. Alderman Dorchinecz had been contacted by residents of his Ward, and he felt the issue should return to the Ordinance Committee, as this is his Ward and he was unable to attend the Committee or Council Meeting for the vote. He had spoken with Fire Chief Crews to verify that an emergency vehicle such as a fire truck could navigate through the parked cars if necessary. Chief Crews confirmed that they could, although it is a tight fit and they may have to approach from opposite ends of the block to reach a fire if necessary. Much discussion was held regarding an Ordinance, in place for approximately 20 years, which

states that it is a violation to block a driveway with a parked car. As there is not staffing to address this on every narrow street in Taylorville, it would be enforced by complaint calls to the Police Department. Mr. Kretzer stated that he would be making those calls to allow access in and out of this driveway safely. The Ordinance will be sent back

Mayor Barry asked if any member of the public desired to speak to the Council.

Mayor Barry also noted that Mr. Jim Dennis has resigned from the Cemetery Board. He had been a member of this board since 1989, serving for 30 years. He is now in Meadow Manor and unable to serve. Mayor Barry had asked his son, Steve, to fill the vacancy but he declined. Mayor Barry will seek a replacement.
