TAYLORVILLE OPTIMIST CLUB - 4^{TH} OF JULY DONATION

This is the second year of a three-year commitment, with \$2,500.00 to come from the Hotel/Motel Tax Fund and \$2,000.00 from the General Fund. Roll Call - Alderman Budd, Burtle, Dorchinecz, Jones, Lanzotti, Olive, Vota, and Walters voted YEA. The Mayor announced the motion carried.

FY 2018/2019 BUDGETS

Motion by Alderman Budd and seconded by Alderman Walters to forward the following FY2018/2019 Budgets: Police, Street, Sewer, Garbage, Motor Fuel Tax, Band, and Administration to the City Treasurer for further refinement. Roll Call - Alderman Budd, Burtle, Dorchinecz, Jones, Lanzotti, Olive, Vota, and Walters voted YEA. The Mayor announced the motion carried.

TREASURER'S REPORT

BUSINESS FROM THE PUBLIC

Mayor Barry asked if anyone in the audience would like to address the Council.

PLAN COMMISSION RECOMMENDATIONS

Chairman Hauser stated that the Plan and Zone Commission had met in the basement of the Municipal Building and had listened to the Curveys regarding their plans to renovate the former South School into apartments. They have no plans for additional buildings on that property. There was some discussion and opposition by the neighbors of the property, citing various concerns: mold in the building, mine subsidence area, the potential of low rent tenants and the effect on their property values and neighborhood. There was a motion made and the Plan Commission voted unanimously (7-0) to recommend to the City Council to approve the rezone from Residential (R-1) to Residential (R-2) property located at 1004 W. Prairie and adopt the corresponding ordinance.
