WATER TREATMENT PLANT - PLOCHER CONSTRUCTION PAY REQUEST #16

LIQUOR LICENSE CHANGES

ANNUAL TAX LEVY ORDINANCE

Motion by Alderman Budd and seconded by Alderman Olive to direct the City Clerk's Office to prepare an Ordinance, that pursuant to the Truth-in-Taxation Act, the sum of \$2,891,346.34 for the City's current Fiscal Year 5/1/18 to 4/30/19 upon the taxable property in the City, which amount is less than 105% of the amount extended, or estimated to be extended, upon the final aggregate levy of the preceding fiscal year; and a Truth-in-Taxation Public Hearing is not required. This includes a maximum levy of \$274,858.34 for the Taylorville Public Library. Roll Call - Aldermen Budd, Burtle, Dorchinecz, Jones, Olive, Vota, and Walters voted YEA. The Mayor announced the motion carried.

PAYMENT OF BILLS

Motion by Alderman Budd and seconded by Alderman Dorchinecz to authorize payment of the bills. Roll Call - Alderman Budd, Burtle, Dorchinecz, Jones, Olive, Vota, and Walters voted YEA. The Mayor announced the motion carried.

BUSINESS FROM THE PUBLIC

Mayor Barry asked if any member of the public desired to speak to the Council. City Attorney Romano reported that 56 Ordinance Violation cases were heard at the last court date. There has been progress made with collections.

Motion by Alderman Dorchinecz and seconded by Alderman Burtle to adjourn. Motion carried (7-0).
