## Approval to Hire a Police Officer

Chairman Bryant explained this is a replacement for an Officer who recently left employment.

Motion by Alderman Wilson and seconded by Alderman Dorchinecz to recommend to the City Council to approve to hire one Firefighter for the Taylorville Fire Department and direct the Mayor to send a letter of approval to the Board of Fire and Police Commissioners. Motion carried 4-0.

## Approval to Bid and/or Advertise Plant Operator 1 - Water Department

Motion by Alderman Wilson and seconded by Alderman Dorchinecz to recommend to the City Council to Bid and/or Advertise a Plant Operator 1 position at the Water Treatment Plant. Motion carried 4-0.

#### Public Official's Salaries

Chariman Bryant distributed a proposal for the Elected Officials salaries. Alderman Dorchinecz believes the numbers in the proposal need to be higher to get fair salaries to match the economy. Over the past four years the cost of living has increased by 19.1% and the Elected Officials only received a total of an 8% increase. Alderman Mitchelson agreed. Chairman Bryant asked the Committee to put together some numbers and bring it back to the next Personnel Committee for further discussion.

#### Police Department Sick time

Sick time for Police Officers has been added incorrectly for several years. There are a total of 10 Police Officers who are owed time totaling 519 hours.

#### Public Official's Salaries

Alderman Mitchelson proposed the City Clerk and Treasurers salaries be raised 10% above the Deputy Clerk and Deputy Treasurer with yearly raises following the AFSCME contract. Mayor Barry advised AFSCME will be receiving a 5% increase on January 1, 2025 and suggested 15% to keep the gap. After a short discussion it was suggested to increase the base salaries of the City Clerk and Treasurer to \$66,000.00 per year and the Mayors salary to \$72,000.00 per year. Alderman Skultety believes the Treasurer salary should be higher. Chairman Bryant suggested \$70,000.00 for the City Clerk and Treasurer and \$72,000.00 for the Mayor, plus 4% yearly increases in 2026, 2027 and 2028. Alderman Wilson recommended to increase the Alderman's salary to \$1,000.00 per month, \$12,000.00 per year.

Motion by Alderman Wilson and seconded by Alderman Dorchinecz to direct the City Clerk to prepare and recommend to the City Council to approve the Salary Ordinance for the positions of the City Clerk, City Treasurer, Mayor and Aldermen for the 2025-2028 term as follows: City Clerk and City Treasurer base salary at \$70,000.00 per year, and the Mayor base salary at \$72,000.00 per year with each position receiving a 4% salary increase in 2026, 2027 and 2028 and the Aldermen at \$1,000.00 per month. Motion carried 3-1.

Police Chief Wheeler has provided a copy of the policy to City Attorney Romano. Alderman Mitchelson would like to wait until Attorney Romano has looked over this policy before approving.

#### Update on Police Personnel

Sargent Mills will be retiring in January 2025; Chief Wheeler is planning on filling his position with a candidate off the lateral hire list. There are also three Officers that are in the process of testing for the Illinois State Police and if they pass everything will be leaving early next year. Chief Wheeler advised testing for the new hire list for the Taylorville Police Department is scheduled for December 14, 2024 and so far there are three applicants.
