Chairman Walters called the meeting to order at 6:00 P.M.

DOWNTOWNTAYLORVILLE.ORG 2018 CALENDAR OF EVENTS

Marcia Neal Presented the Committee with Downtown Taylorville.org 2018 Calendar of Events.

Motion by Alderman Dorchinecz and seconded by Alderman Vota to recommend to the City Council to approve the 2018 Calendar of Events for Downtown Taylorville.org, which includes: Farmers Market Saturday mornings late April thru October, Thursday meals May 17th, June 21st, September 20th and October 18th, History Walk/Chalk Art Contest June 2nd, Meet the Machines September 8th, Dog Daze September 15th, and Twilight Christmas Parade December 1st. Motion carried 4-0.

SPRAY MATERIALS FOR BUGS AND LARVACIDE

Superintendent Wiseman stated he received a quote from Mug-A-Bug for 5 barrels of Larvacide and 5 boxes of Briquets in the amount of \$9,571.25.

Motion by Alderman Olive and seconded by Alderman Dorchinecz to recommend to the City Council to allow Superintendent Wiseman to purchase 5 barrels of Larvacide in the amount of \$9,065.00 and 5 boxes of Briquets in the amount of \$506.25 from Mug-A-Bug not to exceed the total amount of \$9,571.25. Motion carried 4-0.

<u>PUMPS FOR THE NORTHWEST LIFT STATION, RE-BUILDING COST FOR BUDGET</u>

Superintendent Wiseman advised the Committee that the Northwest Lift Station is the main lift station that all of the others dump into. It is 20 years old and has never been rehabbed. Superintendent Wiseman advised he spoke with Vandventeer Engineering and received a quote of \$150,000.00 to update it, this includes a new generator. Superintendent Wiseman stated he is going to put this in the FY 2018/2019 Budget.

NEW CONTROL CABINET FOR LONG/CLEVELAND LIFT STATION

Superintendent Wiseman advised the Cleveland/Long Lift Station Cabinet has not been replaced since it's been installed in 1997. Superintendent Wiseman estimated \$30,000.00 to replace this. Superintendent Wiseman stated he is going to put this in the FY 2018/2019 Budget.

NEW CONTROL CABINET FOR PRISON

Superintendent Wiseman advised the Prison Lift Station Cabinet has not been replaced since it's been installed in 1991. Superintendent Wiseman estimated \$30,000.00 to replace this. Superintendent Wiseman stated he is going to put this in the FY 2018/2019 Budget.

REQUEST FOR EIGHT COLLEGE STUDENTS

Superintendent Wiseman is requesting to have 8 college students this year to keep up with the clean up. He advised last year the department had 6 and they were unable to get the striping done or curbs painted.

Motion by Alderman Dorchinecz and seconded by Alderman Olive to recommend to the City Council to allow Superintendent Wiseman to hire 8 college students for the Street Department for summer help. Motion carried 4-0.

SCHOOL ZONE SIGN-CHEROKEE & BIDWELL

Chairman Walters advised Central School currently has no school cross walk signs. Also, the standard color for the signs has changed. Chairman Walters is recommending to update all school zone signs and have some put up at Central School. Mayor Barry would also like no texting or cell phone usage signs put up in the school zones. Superintendent Wiseman received a quote from Hall Signs in the amount of \$3,862.41 to replace all school zone signs and a quote from Rice Signs in the amount of \$962.50 for 25 no texting or cell phone usage signs. Mayor Barry suggested for Superintendent Wiseman to receive quotes from local business for the signs. Alderman Olive recommended the lighted solar powered signs; he stated they are very eye catching and cost approximately \$1,752.00 per sign.

Motion by Alderman Vota and seconded by Alderman Olive to recommend to the City Council to allow Superintendent Wiseman to receive local quotes for school zone and no texting or cell phone usage signs and present to the Committee at the next Council Meeting. Motion carried 4-0.

SUPERINTENDENT'S REPORT

Superintendent Wiseman advised the department has been tearing down houses, cutting trees on Stevenson, hauling dirt to fill in holes from the houses that have been tore down, patching streets and having plows out for the ice & snow.

Superintendent Wiseman advised the Aldermen that it is time to purchase CA7 rock to start filling in the alleys if needed.

Alderman Vota suggested Superintendent Wiseman to check Sangamon Road where the culverts were put in, as it is starting to settle.

ANY OTHER MATTERS

Chairman Walters spoke about the up coming March clean up days. Superintendent Wiseman suggested to have it in April this year. The Committee agreed with this. Superintendent Wiseman advised this would be all 4 Saturdays in April from 7 A.M. - 3 P.M.

Mayor Barry stated he spoke with the restaurant chain engineer and a road will need to be put in and it would be on Kim Morton's property. He has spoken with her and so far she seems to be ok with this. Superintendent Wiseman stated the next step is having the traffic study with IDOT done, and advised this can take 3-4 months so it would be best to get this going as soon as possible. Also, the Traffic Study, Topographic Survey, Hydraulic Study, Construction Plans, Intersection Design Study, and Signal Plans are reimbursable through the TIF District.

READ BIDS FOR FUEL

Superintendent Wiseman advised the Committee that the bids were just opened this afternoon and he would like to go over them and compare them to last years and bring them back to Council on April 2, 2018.

READ BIDS FOR SIDEWALK AND CURB, CONCRETE

Superintendent Wiseman advised the Committee that the bids were just opened this afternoon and he would like to go over them and compare them to last years and bring them back to Council on April 2, 2018.

BOBCAT MILL

Superintendent Wiseman stated he went to Bobcat of Springfield. They have a 2 year old used bobcat mill for sale for \$9,500.00. This mill is in very good shape for the price; a new one would cost \$17,862.60. Alderman Vota suggested renting one or seeing if the township has one the City can borrow. Superintendent Wiseman advised he will check prices for a rental and bring back to the Committee next month.

PIPE CULVERT LINERS FOR 16" AND 8" FOR EAST LAKESHORE DRIVE AND EASTWOOD

Superintendent Wiseman advised the Committee that a silt pond blew a hole and this has caused culverts to collapse under ground. There are 3 culverts that need new pipes. A 16" pipe on East Lakeshore Dr. would cost \$7,824.00. There are two 8" pipes on Eastwood Dr., this would be a total of \$2,726.00. Larry Langen will pull the pipes through for \$3,000.00, making the total of the project \$13,550.00.

Motion by Alderman Vota and seconded by Alderman Dorchinecz to recommend to the City Council to allow Superintendent Wiseman to replace one 16" pipe one East Lakeshore Dr. and two 8" pipes on Eastwood Dr. at a total not to exceed \$13,550.00. Motion carried 4-0.

\$400,000 WORTH OF OVERLAY

Superintendent Wiseman stated he has taken \$400,000.00 out of Motor Fuel Tax to do overlays. He would like to overlay West Main Cross from Webster to Houston, and this would be approximately \$239,668.90. He would also like to overlay Webster from Main Cross to Walgreens. This would be approximately \$102,605.15. Superintendent Wiseman stated Lincoln Land Way is in bad shape and needs to be fixed also, but he still needs to get measurements for a total on this.

Motion by Alderman Olive and seconded by Alderman Dorchinecz to recommend to the City Council to allow Superintendent Wiseman to overlay West Main Cross from Webster to Houston for an approximate cost of \$239,668.90, and Webster from Main Cross to Walgreens for an approximate cost of \$102,605.15. Motion carried 4-0.

Alderman Dorchinecz stated he would like to check out West Main Cross with Superintendent Wiseman due to some complaints on the curbs before the overlay is started.

SUPERINTENDENT'S REPORT

Superintendent Wiseman stated they just started the demolition on the 11th house, and after this they have another lined up on Cottage Street.

Superintendent Wiseman advised he has 3 employees going to a free 2 day class on April 1st and this is on how to operate the Vactor.

ANY OTHER MATTERS

Alderman Dochinecz advised the Committee that a procedure needs to be put in place for commercial property that needs help with sidewalk/gutters. Shafer-Perfetti & Assalley Funeral Home is wanting to improve the sidewalks. Superintendent Wiseman stated there is \$50,000.00 in the sidewalk fund and \$30,000.00 in the curb/gutter fund.

Superintendent Wiseman advised the Committee he spoke to Matt Thomas from Taylorville Memorial Hospital and they are going to close the Walnut St. entrance into the hospital and start using North Main St. entrance. They are wanting to grind down the bricks in the intersection to make a smoother entrance. This would be done at no cost to the City.

Motion carried 3-0.

THS HOMECOMING PARADE-WEDNESDAY OCT 3, 2018

Matt Hutchison, Taylorville High School Principal and Elizabeth Curtin, President of the Student Council, were present to ask approval for the request for the 2018 Homecoming Parade. They asked Mayor Barry to be the Parade Marshall; he gladly accepted.

Motion by Alderman Olive and seconded by Alderman Vota to recommend to the City Council to approve the request and issue a Special Events Permit to Taylorville High School for the Homecoming Parade be held on Wednesday, October 3, 2018 beginning at 5:30 P.M., with the school providing a current Certificate of Insurance at that time. Motion carried 4-0.

INDUSTRIAL PARK

Ken Hart, Mary Renner and Phil Martin were in attendance to discuss the new Industrial Park. Phil Martin, Martin Engineering, presented a topographic map of the Industrial Park. Mr. Martin addressed the Committee regarding the layout of the road asking if a cul de sac will be at the end of the road or if for long range plans the City would extend the road all the way through to Breckenridge Rd. He advised all plans would have to be approved by I.D.O.T.

They discussed the name of the proposed road, which will have to be approved by 9-1-1; and whether to use rock or asphalt and the width. The Fire Department will be contacted to determine what is needed for the vehicles to maneuver in and out of the Industrial Park.

Mr. Martin asked the Committee how they wanted to proceed, as he is scheduled to have his design done by late June. He was advised the plans will have to go through the Plan Commission. Alderman Jones advised he would contact City Clerk Julie Lilly and HBO Officer George Calvert.

REHAB NORTHWEST LIFT STATION

Motion by Alderman Vota and seconded by Alderman Dorchinecz to recommend to the City Council to hire Vandevanter Engineering at a cost not to exceed \$98,570.95 for the Rehab of the Northwest Lift Station pending the confirmation from the City Treasurer that the funds are available. Motion

Carried 4-0.

STEAK N SHAKE SANITARY SEWER

There was a lengthy discussion regarding whether or not the City would provide for the sanitary sewer for Steak N Shake. Alderman Dorchinecz asked where the funds were going to come from he stated he would vote yes to the City paying if Alderman Walters, Chairman of the Street and Sewer Committee and Alderman Budd, Chairman of the Finance Committee confirmed the money is in the budget. Alderman Budd advised some items in the budget would have to be cut to get the development started. Alderman Jones recommended using the overage in the Utility Tax Fund. Superintendent Wiseman advised this project is being completed by the City and Phil Tullis Excavating, Mr.Tullis is charging \$19.20 a foot for the excavating.

Motion by Alderman Dorchinecz and seconded by Alderman Vota to recommend to the City Council to approve proceeding with the sanitary sewer for Steak N Shake with the funds coming from the overage from the Utility Tax at a cost not to exceed \$58,421.76. (This project will be completed by the City and Phil Tullis Excavating) Motion carried 4-0.

HSHS SANITARY SEWER

Alderman Vota stated he would like to make a clarification. The Romano Construction Group are the developers of the HSHS project not Dr. Delvalle; he is an employee of HSHS. He also stated he would be abstaining as his wife is employed by Dr. Valle. There was a lengthy discussion

regarding funds. Alderman Dorchinecz again voiced concerns regarding where the funds were coming from stating if Alderman Budd, Finance Committee Chairman tells him the funds are available he would vote for the project. Alderman Olive stated this is an opportunity to move forward; the City has to do what it can to attract new business.

Superintendent Wiseman advised this project is being completed by the City workers and Phil Tullis Excavating, Mr. Tullis is charging \$19.20 a foot for excavating.

Motion by Alderman Olive and seconded by Alderman Dorchinecz to recommend to the City Council to proceed with the Sanitary Sewer Project for the Romano Construction Project for HSHS at a cost of \$61,282.00. (This project will be completed by the City and Phil Tullis Excavating). Motion carried 3-0-1.

SUPERINTENDENT'S REPORT

Superintendent Wiseman reported the Department has been busy working on the following projects:

- Finished work on Cherokee Street, now working on Webster
- Taking trees down at the school
- Installed pipe on E. Lakeshore Drive where the Silt Dam broke; pulled new plastic lines through where the ground was bored.
- The summer helpers are cleaning alleys and mowing grass and helping with mowing at the Cemetery getting ready for Memorial Day. They will be painting sidewalks and curbs.

ANY OTHER MATTERS

City Engineer Joe Greene presented the Committee with copies of pages from the Illinois General Assembly of Illinois Statutes for Local Government (50 ILCS 510/) Local Government Professional Services Selection Act.

There was discussion regarding how to proceed with West Main Cross. Alderman Dorchinecz stated he has had complaints that the overlay is so high in some areas that the curb is only 1" high. He asked City Engineer, Joe Greene his opinion on proceeding with the overlay. His recommendation is to mill the street but not down to the brick as has been discussed, take care of defective curbs one block at a time and to do the same with the pan and gutters repair/replace one block at a time, when the pans are covered there isn't proper drainage. Alderman Walters stated that in repairing one block at a time the curbs and gutters aren't going to match as the color will be different. Engineer Greene stated it is being done this way all over the state do to finances.

Superintendent Wiseman was asked to get quotes from PSI and Truman Flatt for the overlay project. MFT funds are going to be used for West Main Cross.

Alderman Budd stated all Wards should be handled the same way as the funds for Cherokee Street came from his Ward money not MFT funds. Alderman Jones stated he understands that in the past it took six years for their Ward to save the funds to do the overlay of West Main Cross. This year MFT funds have been set aside for this project. It is a main roadway used for all the parade routes leading from the Fairgrounds.

Chairman Walters called the meeting to order at 6:00 P.M.

TAYLORVILLE CHRISTIAN CHURCH STORM SEWER

There was a lengthy discussion regarding the cost of the Taylorville Christian Church Storm Sewer. The cost is determined by the size of the pipe, the total cost is \$2,600.00.

Mr. Gary McNeely was in attendance and advised that his plumber, Mr. Blakley, recommended a different way to do the drainage than originally planned. Mr. Blakley contacted Superintendent Wiseman for a quote. Superintendent Wiseman initially quoted \$1,000.00 for this project.

Mayor Barry stated that Superintendent Wiseman did not have the Code Book in front of him when he quoted \$1,000.00. The final charge was actually \$1,600.00 more than quoted, for a total of \$2,600.00. Mayor Barry is recommending splitting the cost and charging the church \$1,300.00. There was a lengthy discussion between the six Alderman in attendance; some felt this would set a precedence for others in the future.

Motion by Alderman Dorchinecz and seconded by Alderman Vota to recommend to the City Council to have the Taylorville Christian Church pay the full amount of \$2,600.00. Motion 2-2.

Chairman Walters asked that due to a tie vote to direct the City Clerk to put the Taylorville Christian Church Storm Sewer on the July 2, 2018 City Council to be voted upon by the whole Council and to invite Mr. McNeely.

TRANSFER OF PROPERTY

Mr. Sheridan Pulley was in attendance to discuss a large tree located on a parcel of property behind his business at 901 E. Main Cross. He is interested in purchasing the property for the sole purpose of cutting down the tree. He could possibly put up a small building in the future, but he has no plans to at this time.

If he cannot purchase the property, he is asking that the City remove the tree, as it is dying and could cause considerable damage to his property. He was advised there are State Statutes that determine how property is sold by a municipality. This will be researched and brought back to next month's Street & Sewer Committee Meeting.

BIKE TRAIL DISCUSSIONS

Mr. Bud Altman, Vice Chairman of the Lincoln Prairie Trail Conservancy, was present to discuss placing signs up for the bike trail, at their expense.

Motion by Alderman Olive and seconded by Alderman Vota to recommend to the City Council to allow the Lincoln Prairie Trail Conservancy to place two signs with their logo on East Main Cross and Paw Paw at their expense. Motion carried 4-0.

WALNUT STREET PROJECT

The Committee discussed the Walnut Street Project. Bids were taken on June 15, 2018 by the Illinois Department of Transportation. The lowest bid was received from Truman L. Flatt & Sons Co., Inc. for \$820,557.01. The City's "LPA" share is approximately \$185,000. There was a lengthy discussion regarding use of the Motor Fuel Tax Fund. During this discussion, it was noted by Chairman Walters that Treasurer Nation start a spreadsheet that shows how much money is borrowed from the Utility Tax Street Maintenance Fund that will be paid back when MFT money is available to pay back that loan. The amount of money that was allocated for the resurfacing of West Main Cross is to be earmarked and not spent this year on any other project unless it is for prep work for the West Main Cross Resurfacing Project. If not used for that purpose, it is to be combined with next years MFT money to be allocated for said project. At this time the City's share will be paid using Utility Tax Overage Funds which will be repaid by the Motor Fuel Tax Funds when Treasurer Nation receives the approval from the State to transfer the funds.

Treasurer Nation received confirmation from the State to spend funds for the Motor Fuel Tax Fund for the January 2018 through December 2018 time frame but not the January 2017-December 2017 time frame. The State now has the proper paperwork to release the MFT Funds for 2017.

Alderman Dorchinecz advised the use of Utility Tax Funds will be on the next Finance & Ordinance Committee Meetings.

Motion by Alderman Dorchinecz and seconded by Alderman Olive to recommend to the City Council to authorize and direct the Mayor to sign the I.D.O.T. Local Public Agency Agreement for Federal Participation for Walnut Street. Motion carried 4-0.

LINCOLN LAND WAY ROAD

The Lincoln Land Way Road was tabled until after budgets are complete.

STEAK N SHAKE SANITARY SEWER

Mayor Barry advised that City Attorney Romano had received an email regarding the Steak N Shake Sanitary Sewer and forwarded the email to the Aldermen. Superintendent Wiseman is requesting information regarding easements.

HSHS SANITARY SEWER

No action taken, no additional information has been provided at this time.

INTERGOVERNMENTAL AGREEMENT WITH STATE DISTRICT 6

Superintendent Wiseman stated that the Street Department recently helped mow Mt. Auburn Road and helped to fill in holes. He advised that the State helps the City also, as they use the vactor on the drains on Park Street. He is recommending the City enter into an Intergovernmental Agreement with State District 6.

Motion by Alderman Dorchinecz and seconded by Alderman Olive to recommend to the City Council to direct the City Attorney to prepare an Intergovernmental Agreement with State District 6. Motion carried 4-0.

SUPERINTENDENT'S REPORT

Superintendent Wiseman reported the Department has been busy working on the following projects:

- Department tore down one house and two garages
- Have been working on patching and culverts
- Department had to replace a sewer line in the Kenton Addition
- Have had six trees cut down
- The summer helpers have been busy with painting and cleaning up trash and brush
- Lowes Paving have been striping the streets

ANY OTHER MATTERS

Mayor Barry and Alderman Olive discussed a drainage problem located in the Esther, Wilkinson area. Mayor Barry advised there is a Drainage District and he will contact them to set up a meeting. Mayor Barry will be forming a Business District Committee and asked that the Alderman attend this open meeting. He would like to recommend that they meet at least once every three months.

Superintendent Wiseman stated there is an Ordinance on tall grass and is recommending that there be an Ordinance for trees and tall weeds growing inside fences around town. He advised the department had to clean a whole section of trees, etc. growing inside a fence line when the new sidewalks were poured on Cherokee Street and now the new sidewalks are being covered by this brush.

Motion by Alderman Olive and seconded by Alderman Vota to adjourn. Motion carried 4-0. Meeting adjourned at 7:47 P.M.

Motion by Alderman Vota and seconded by Alderman Olive to recommend to the City Council to approve the request and grant a Special Events Permit for the annual Knights of Columbus Tootsie Roll Drive on Friday, September 21, 2018 & Saturday, September 22, 2018 from 8:00 A.M. to 5:00 P.M. at the corner of Webster and Main Cross upon receipt of a current Certificate of Insurance. Motion carried 3-0.

PAVEMENT MARKINGS & ARROWS-WEBSTER STREET TO CHENEY STREET

Superintendent Wiseman discussed the pavement markings & arrows on Spresser Street from Webster Street to Cheney Street. Mayor Barry advised he thinks the quote from Vision Infrastructure Construction Corp is a fair price and he is not against it, but in the future, he wants Superintendent Wiseman to present multiple quotes for projects.

Motion by Alderman Vota and seconded by Alderman Olive to recommend to the City Council to allow Superintendent Wiseman to allow Vision Infrastructure Construction Corp. to do the pavement markings and arrows on Spresser Street from Webster Street to Cheney Street at a cost of \$6,054.12. Motion carried 3-0.

PERSHING LIFT STATION-VARIABLE FREQUENCY DRIVE AND INSTALLATION PROPOSAL

Superintendent Wiseman presented a proposal from Vandevanter Engineering for a replacement pump for the Pershing Road Lift Station.

Motion by Alderman Vota and seconded by Alderman Olive to recommend to the City Council to allow Superintendent Wiseman to have Vandevanter Engineering replace the failed drive with an ABB Variable Frequency Drive complete with a keypad mounting kit at a cost of \$5,605.32, for the Pershing Road Lift Station. Motion carried 3-0.

PROTOCOL FOR LIFT STATION ALARMS

Police Chief Hile and Dispatcher Leah Avila were in attendance with a concern regarding protocol for the lift station alarms. Police Chief Hile advised he had discussed the alarms for the lift stations at his July Emergency Services Committee Meeting; he stated from January 1, 2018 through June 28, 2018, the Department received 78 lift station alarms.

Dispatcher Avila advised when these calls come in they continue to call until someone physically goes out and resets the alarm. The Committee asked Mrs. Avila what the protocol is for the dispatchers regarding the calls. She advised that they call Superintendent Wiseman who then calls someone to go to the lift station; if no one answers he responds. Chief Hile's suggestion was to have these calls sent directly to someone from the Street & Sewer Department. Superintendent Wiseman advised there would not be anyone in the office to answer the calls after hours and weekends, which is why he thinks it should stay at the Police Department. There was a recommendation to pay someone a flat rate to carry a pager for calls; Superintendent Wiseman advised he did not think that would work.

Mrs. Avila explained that the calls are continuous until answered and is worried that someone having an emergency would have to be postponed due to the phone ringing continuously. She advised there was recently a suicide, and while she was trying to get all the personnel in place, Officers, Coroner etc. the lift station alarms kept ringing in. She was told you can hit #7 to disarm it; she advised she does do that, but until someone physically goes to the lift station it keeps ringing in. Chief Hile stated Wareham's installed the system but a third party answers their phones. He thinks the calls should be forwarded to Superintendent Wiseman's phone since they have to forward all the calls to him anyway. Wareham's can notify the call center to send calls directly to him and cut out the extra step. The Committee asked how they would be able to maintain a call log if using an outside call system. Mrs. Avila advised that the Street Department receives an e-mail for every call.

Chairman Walters advised this issue will be an agenda item for next month's agenda.

PUMP-HENRIETTA LIFT STATION

Superintendent Wiseman advised he has included the purchase of a new pump for the Henrietta Lift Station in his budget. The Committee advised him to proceed with purchasing a rebuilt pump at this time and to wait on purchasing a new pump until after the Audit is completed. This will remain an agenda item on next months agenda.

REBUILD OLD PUMP-HENRIETTA LIFT STATION

Motion by Alderman Olive and seconded by Alderman Vota to recommend to the City Council to allow Superintendent Wiseman to have the old pump for the Henrietta Lift Station rebuilt by Vandevanter Engineering at a cost not to exceed \$5,484.53. Motion carried 3-0.

OPTIMIST CLUB PROPOSAL
