SUPERINTENDENT'S REPORT

Superintendent Mann advised he has a meeting with Dunn's for the Veteran's parking lot to get the project scheduled. He needs volunteers to help set up for Chillifest the first weekend in October. He updated the Committee on possible replacement of the Street Sweeper. It will cost approximately \$40,000.00 to make needed repairs; the repairs are a temporary fix. He is gathering quotes on different types of equipment to replace the sweeper, with costs ranging from \$100,000.00 to \$350,000.00. Quotes will be given to all Aldermen to review. Workers have been hauling lime and cutting trees. Superintendent Mann also brought forth some concerns with billing issues.
