CLASS O LIQOUR LICENSE - TANGLES SALON

711 WEST POPLAR

This is in reference to the Paw Paw Street drainage issue to resolve the flooding in that area. Roll Call - Aldermen Bryant, Budd, Dorchinecz, Driskell, Lanzotti, Olive, and Skultety voted YEA. The Mayor announced the motion carried.

10 SHARED PRINCIPLES

These principles relate to the change in the culture of policing and build trust between law enforcement and communities. The motion carried (7-0).

BUSINESS FROM THE PUBLIC

Mayor Barry asked if any member of the public desired to speak to the Council. No one present addressed the Council. Mayor Barry updated the Council on a planned meeting this week between the City of Pana, Mayor Barry. Senator Andy Manar, and the engineers working on the Bike Trail Bridge replacement project. They will be seeking lower bids and/or additional means of financing for this project due to the increased projected costs. Mayor Barry will provide an update as more information is received.

Motion by Alderman Dorchinecz and seconded by Alderman Olive to adjourn. Motion carried (7-0).
