Chairman Jones called the meeting to order at 6:00 P.M.

### Review Liquor License Classifications

Chairman Jones welcomed the audience members who were attending the meeting to observe and participate in the discussion regarding the licensed video gaming locations throughout the City. They were advised that no motion regarding the video gaming would be made tonight but that the Committee wanted their input prior to making any decisions. Mayor Brotherton briefly explained the history and events that led up to the State of Illinois establishing the current video gaming legislation. He also explained what the City's original intent was in attempting to utilize the liquor license classifications as a way to limit the number of video gaming locations within the City. He mentioned that several of the current video gaming locations had obtained the required liquor licenses by claiming to be a restaurant when in reality little or no food is being prepared or sold at those locations. Several members in the audience voiced their concerns that they had already invested considerable amounts of money at their locations and they did not feel the City should force them to close. Chairman Jones read the definition of a restaurant as it is stated in Title 3 Chapter 3 Section 3-3-1B. Mayor Brotherton pointed out he and the other City Council Members believed that the restaurants being licensed would fit this definition when they approved the changes in the liquor license classifications.

The number of locations within the City licensed to allow video gaming was also discussed. The majority of Aldermen stated that they feel no additional video gaming locations should be allowed. Alderman Dorchinecz stated that he feels it is unfair to limit the number of locations and that anyone meeting the qualifications should have the same opportunity to open and operate the same type of video gaming sites within the City.

Several Aldermen stated that because the locations had been allowed to open and operate in violation of the ordinance they felt that it would be wrong to force any of the existing locations to close now. The Mayor stated until there was some clarification on this issue he would not be approving any additional liquor licenses under the classifications that would allow any additional video gaming locations within the City.

Liquor License Classifications

Chairman Jones presented his proposals for amending Class C and C-1 and Class A and A-1 Liquor Licenses. His suggestions were to amend the definition of Restaurant to include 'primary business; follow Public Health guidelines, grease traps, etc. with periodic health inspections; define limits percentage wise for food & drink sales only; define Tavern/Bar better; include definition of a Gaming Parlor and prohibit such; and include a 6 month probation of Class C Liquor License before a Class C-1 will be issued by the Mayor's recommendation.

Motion by Alderman Burtle and seconded by Alderman Budd to recommend to the City Council to direct the City Attorney to amend the City Code relating to Liquor License Classifications to include items presented by Chairman Jones and any other recommendations and to present a draft ordinance for the Ordinance Committee's review. Motion carried 4-0.

Cable Television Ordinance

Mr. Billy Williams and Mr. Adam Vocks with Computer Techniques, Inc. (CTI) dba CTI-Fiber explained to the Committee they have applied for a State issued Authorization to provide Cable Service instead of a Cable Franchise with the City. In meeting with CTI the City has found that Ordinance No. 2544 approved July 1995 needs to be revised and updated to accommodate new technology and new state laws.

Motion by Alderman Burtle and seconded by Alderman Budd to recommend to the City Council to direct the City Attorney to update and amend Ordinance No. 2544 to accommodate current technology and new state laws. Motion carried 4-0.

FY 2015/2016 HBO Budget

HBO Officer, George Calvert presented the FY 2015/2016 HBO Budget stating it is the same as last year's except for the addition of a new 2015 Ford F250 Super Cab 2wd Pickup which was approved at the February 17, 2015 City Council Meeting.

Motion by Alderman Burtle and seconded by Alderman Vota to recommend to the City Council to forward the proposed FY 2015/2016 HBO Budget to the Finance Committee. Motion carried 4-0.

Amendments to Liquor License Ordinance

City Attorney Romano presented a revision of Sections 3-3-1, 3-3-4, and 3-3-5 of the City Code regarding liquor licenses. Mayor Brotherton stated that the liquor license for restaurants with gaming machines are being abused not only in Taylorville but statewide. The City is trying to undo what's been done, as is the State. The City does not want to run anybody out of business but they must comply with the law. The Committee, other Aldermen in the audience, and many liquor license holders discussed the proposed revisions and suggestions for additional changes.

Motion by Alderman Vota and seconded by Alderman Budd to recommend to the City Council to direct the City Attorney to make further revisions to the Liquor Code as may be directed by the Chairman or by the Acting Ordinance Committee Chairman. Motion carried 3-0.

Revision to Ordinance #2544 Regarding Cable TV Franchises/Cable Service Provider Fee Ordinance/Ordinance Establishing Standards for Construction of Facilities on Right-of-Ways

City Attorney Romano presented drafts of two Ordinances that the Illinois Municipal League recommended passage of in 2007 but the City never did. He is recommending the City pass them now and update Ordinance #2544 from 1995 regarding Cable TV Franchises to bring it up to today's technology.

Motion by Alderman Budd and seconded by Alderman Vota to recommend to the City Council to direct the City Attorney to draft the following three ordinances for consideration for adoption by the City Council at the next City Council Meeting: Amend Cable TV Ordinance No. 2544, Cable Service Provider Fee, and Establishing Standards for Construction of Facilities on Rights-of-Way. Motion carried 3-0.

Amendment to City Code (8-5-4 I 2 (d) Regarding Sewer Fees

The City Council recently denied setting up payment plans for two individuals who had sewer repairs completed on their property but the City paid for upfront. City Attorney Romano presented a draft ordinance amending the City Code to address reimbursement from individuals to the City when the City has paid for the sewer repairs upfront.

Motion by Alderman Vota and seconded by Alderman Budd to recommend to the City Council to adopt the Ordinance as presented by the City Attorney to amend Section 8-5-4 I 2 (d) regarding liability of property owner for building sewer repairs. Motion carried 3-0.

#### HBO Updates

The City Attorney presented language to amend Section 4-4-13A of the City Code regarding neglected property; and stated he would prepare an Ordinance to amend Section 4-4-13A of the City Code for the City Council to consider at its April 6<sup>th</sup> City Council meeting and asked the Mayor to place this on the Agenda for the April 6<sup>th</sup> City Council meeting.

HBO Officer George Calvert presented pictures and updated the Committee of property violations and cleanups.

#### Charleston Agreement

The City Attorney advised that the City and Charleston have agreed on the latest revision to the Intergovernmental Cooperation Agreement regarding billing for the ambulance services. The City Attorney requested the Mayor to place on the April 6<sup>th</sup> City Council Agenda the adoption of a Resolution approving said revised Intergovernmental Cooperation Agreement.

#### MABAS Agreement

The City Attorney reported that Fire Chief Crews is obtaining numbers to fill in the blanks on the MABAS Agreement and this will be on the next City Council or Committee agenda when ready.

### Liquor License Classifications-Micro Brewery & Bowling Alleys-Dram Shop Liquor Liability Insurance Language

The Committee discussed the proposed draft ordinance as prepared by the City Attorney regarding two (2) new Liquor License Classifications and language referring to Dram Shop Liquor Liability Insurance. The Class I and Class I-1 refer to a "Brew Pub" and Class J and J-1 refer to "Bowling Alleys". The applicant that intends to sell alcoholic liquors for use or consumption on the licensed retail premises must have in force liquor liability insurance coverage for that premises for the entire term of the requested liquor license. The Committee discussed limiting the Class I-1 to two (2) Liquor Licenses.

Motion by Alderman Vota and seconded by Alderman Budd to recommend to the City Council to direct the City Attorney to amend the proposed Ordinance as presented with the addition of limiting the Class I-1 Liquor License to (2) two. Motion carried 4-0.

### Insurance Issues Re: Sidewalk/Street Blocking & Dumpster Permits (Section 3-11-8 of the City Code)

Chairman Jones presented to the Committee a request to incorporate similar insurance language to Section 3-11-8 pertaining to Sidewalk/Street Blocking & Dumpster Permits, as found in other Sections of the Taylorville City Code.

Motion by Alderman Vota and seconded by Alderman Budd to recommend to the City Council to table incorporating the proposed insurance language to Section 3-11-8 pertaining to Sidewalk/Street Blocking & Dumpster Permits until further clarification from the City Attorney and the City's Insurance Carrier. Mayor Brotherton advised that he would speak with the landowner or the party representing the landowner to see if they wanted to move forward on the request.

### Special Use Amendments

The Committee discussed the proposed Ordinance adding Special Uses in R-1, R-2 and C-1 Districts to the Taylorville City Code. The City Attorney suggested several changes.

Motion by Alderman Vota and seconded by Alderman Budd to recommend to the City Council to direct the City Attorney to amend the proposed Ordinance with the changes as discussed and direct the Mayor to set a Public Hearing and a Plan Commission Meeting at 6:00 P.M., July 20, 2015. Motion carried 3-0.

### Sign "No Parking This Side"/Spillway Bridge

Since the new Spillway Bridge has been installed, it has been observed that people have been parking from the top of the hill down to the bridge in the gutter area.

Motion by Alderman Vota and seconded by Alderman Budd to recommend to the City Council to direct the City Attorney to prepare an Ordinance placing a sign "No Parking this Side" on the north side of the Spillway Bridge. Motion carried 3-0.

### Portable Storage Units

Mayor Brotherton informed the Committee that the Grandview Outlet store located at the north end of the strip mall on Webster Street is currently selling and renting cargo freight containers. They are actually using them for storage rental space on the commercial property. Similar types of storage containers are being used at Walmart and several other locations throughout town. The difference with the outlet store is the sheer number of the units and the fact that the units are being sold and rented for use by others.

The Mayor questioned if the City of Taylorville can restrict storage pods and cargo freight containers on commercial and residential properties. Attorney Romano informed the Committee as a non-home rule municipality, the City may regulate/restrict storage pods and/or cargo freight containers through amendments to the zoning code after the appropriate Public Hearing and Plan Commission Meeting.

Motion by Alderman Budd and seconded by Alderman Vota to recommend to the City Council to direct the City Attorney to prepare an Ordinance regarding the regulation/restriction of storage pods and cargo freight containers on commercial and residential properties and refer back to the Ordinance Committee for their review. Motion carried 3-0.

### Water Collection Fees, Parking Tickets and Other City Fees Forwarded to the Collection Agency

Treasurer Nation and Clerk Peabody are requesting that the City Attorney consider amending the Ordinance regarding turning a delinquent bill over to a debt collection agency for collection and for the collection agency to collect 100% of the City's bill and add their fees on top of the bill. Examples of bills for the Water Collection Department would include Water Bills (water, sewer, Sanitary District, CAMP) and Parking Tickets. Examples for the City Clerk's Office would include City Services such as; ornamental lighting, damage to signs or stoplights, NSF checks, mowing & cleanup, vehicle damage, etc.

Motion by Alderman Vota and seconded by Alderman Budd to recommend to the City Council to direct the City Attorney to prepare an Ordinance regarding assessment of attorney fees and collections costs for delinquent accounts if legally permissible. Motion carried 3-0.

### Portable Storage Units

Attorney Romano informed the Committee that the City can regulate Portable Storage Units in residential and commercial areas. The Committee discussed regulating the time limit on the storage units, the height, width and stacking of storage units, setbacks, and screening of outdoor building materials. The Mayor provided the City Attorney with ordinances from other communities regarding portable storage containers in commercial and residential areas.

Chairman Jones called the meeting to order at 6p.m.

**1. Amendments to the C1 and C2 Zoning to Allow for Special Use of an Indoor Firing Range within the City Limits**

Chairman Jones read each section and paragraph of the proposed ordinance and discussion followed after each section and paragraph. Due to this discussion, some minor changes to the proposed ordinance were suggested and are as follows.

The Mayor Brotherton would like to have some local control written in the ordinance on the number of firing ranges inside of city limits under special uses. He would like for that number to be 1. The suggestion was based upon our current population in the city. Should there be an abnormal growth within the city, then he would like the Mayor to have the ability to allow 1 more based upon the population of the city. The ratio of 1 firing range per 10,000 residents of city population as a place to start was suggested.

On page 3 in paragraph 1, it was suggested that there be two paragraphs, an A. paragraph dealing with non automatic weapons and a B. paragraph relating to automatic and class 3 weapons.

On page 4 in paragraph 2, line 1, insert after the word arrows," carried into or out of the firing range

On page 5 paragraph 5, line 4, please insert the word "of" between adult and such .

On page 7, paragraph 16, line 5, it references an operating permit. Should we add the words "or city license" to this paragraph or are we going to have an annual operating permit created with an annual fee of \$50 to \$100? If we create an operating permit with this fee, it would cover HBO time for the annual inspection.

Motion by Alderman Vota and second by Alderman Budd to direct the City Attorney to make the necessary changes to the proposed draft ordinance, and to allow the City Clerk to follow the proper procedure in setting a Public Hearing and meeting of the Planning and Zoning Commission, and to forward the proposed draft ordinance to the Planning and Zoning Commission for a recommendation to the full City Council.
