Taylorville City Tree Board Meeting February 17, 2015

Chairman Barb Grabner-Kerns called the meeting to order on Tuesday, February 17, 2015 at 5:01 P.M.

First agenda item discussed was an Arbor Day Event which would include a possible tree planting. Possible areas mentioned to plant for Arbor Day included Lake Taylorville, the empty lot east of the DMV and an evergreen tree in front of City Hall. Motion to recommend planting an evergreen in front of City Hall was made by Phyllis Wilson seconded by Kira Propst. Motion carried 3-0.

Second agenda item was reviewing the Taylorville Tree Inventory Report Draft put together by Barb Grabner-Kerns. Needs a few updates to make final. The Tree Board reviewed the Recommendations by Tree Board section. They are as follows:

- 1) Plant more trees. We recommend a special line item in the budget of at least \$1,000 for tree planting annually. Additional grant funds and donations should also be sought.
- 2) Diversify species a diverse mix of trees should be planted with no more Maples planted. Maple trees should be removed from the city's recommended street tee list. No invasive species should be planted in public spaces (e.g., Callery Pears). A recommended street tree list is included in the Appendix.
- 3) Make a longer-term plan to remove trees that are dead or in poor condition.
- 4) Have a goal of replacing every tree removed with a new tree from the recommended street tree list. If the location of the tree that is removed is not appropriate for planting trees, plant a new tree elsewhere.
- 5) Focus on maintaining trees with proper pruning, mulching, watering, ect.

Motion was made by Kira Propst to approve the recommendations list seconded by Phyllis Wilson. Motion carried 3-0.

Other items discussed by the Tree Board included their search for two members. Possibly by advertising or Mayor Brotherton making a statement. Also, the Tree Board would like to present the finalized Taylorville Tree Inventory Report to the Street and Sewer Committee and/or City Council.

Motion was made by Barb Grabner-Kerns at 6:03 P.M. to adjourn seconded by Phyllis Wilson. Motion carried 3-0.

Third agenda item discussed was the Arbor Day Event Friday, April 24, 2015 at Christian County Mental Health Workshop. Barb Grabner-Kerns is looking for an oak tree to donate for the planting. The tree is to be planted at 10 A.M. in front of Christian County Mental Health Workshop, 707 Mc Adam Drive. Mayor Brotherton will make a proclamation at the event.

No other matters were brought before the Tree Board.

Chairman Barb Grabner-Kerns called the meeting to order on Tuesday, June 9, 2015 at 5:00 P.M.

First agenda item discussed was the request of Kay Masterson to remove the 3 walnut trees located at 402 N. Pine. The board previously discussed and made a motion for the city to take down the middle tree. The request for an arborist to look at the trees was denied due to the cost. The board discussed the immediate removal of the middle tree and trimming of the north and south trees away from the home and the yard. Richard Hughes will contact a few people to see if they would be interested in purchasing the trees from the city for lumber.

First motion on this item for the middle tree and stump to be removed by the city and the other two trees to be trimmed immediately by the city was made by Phyllis Wilson and seconded by Kira Propst. Motion carried 4-0.

Second motion on this item for Richard Hughes to explore sawmills and/or individuals to purchase the north and south trees on property as well as other trees located on Snodgrass was made by Barb Grabner-Kerns seconded by Kira Propst. Motion carried 4-0.

Second agenda item discussed was the request of Superintendent Dick Wiseman to remove 2 sweet gum trees located at the empty lot east of 1001 E. Stevenson. There are hanging limbs in both trees and the west tree is in poorest condition.

Motion for the city to take down the west tree and remove stump and only trim the east tree as well as plant a replacement shade tree from the approved city tree list was made by Phyllis Wilson and seconded by Kira Propst. Motion carried 4-0.

Third agenda item discussed was the request of Carol Dees to remove 2 birch trees located at 1201 W. Vine. Both trees appear to be dying and are visibly cracked. The homeowner provided pictures to Phyllis Wilson to provide a better view of trees.

Motion for the city to remove both trees and stumps and replace with trees from the approved city tree list was made by Phyllis Wilson seconded by Kira Propst. Motion carried 4-0.

Fourth agenda item discussed was the request of James Maple to remove an

ash tree and a sweet gum tree located at 1000 W. Main Cross. The ash tree is located right on the corner of W. Main Cross and Cheney and is in very poor condition. The sweet gum tree is close to the home as well as the intersection.

First motion on this item for the city to remove the ash tree and stump and the homeowner to replace with a smaller flowering tree was made by Phyllis Wilson seconded by Kira Propst. Motion carried 4-0.

Second motion on this item for the city to remove the sweet gum tree and stump and the homeowner to replace with a smaller tree was made by Phyllis Wilson seconded by Kira Propst. Motion carried 4-0.

Fifth agenda item discussed was recruiting new members. The board welcomed Richard Hughes as the newest member of the board. Discussed putting an ad in the local news paper. No leads on new members.

Sixth agenda item discussed was the resignation of the current acting chairman of the tree board, Barb Grabner-Kerns. She will resign as of September 1, 2015. Will continue as chairman until then.

Seventh agenda item discussed was a maple tree brought to the attention of Kira Propst located at 727 W. Vine. The tree is visibly hollow from the base of the trunk upward. Will formally discuss at the next tree board meeting.

No other matters were brought before the board.

Motion by Kira Propst seconded by Phyllis Wilson to adjourn. Motion carried 4-0. Meeting adjourned at 6:12 P.M.

Second agenda item discussed was the request of Kira Propst to remove a maple tree located at 720 W. Vine. The tree is dead and soft. It drops limbs during storms as well as days when there isn't wind. Concerned that it will fall during a storm on to a home or a car. Homeowner is willing to replace with a medium approved tree from the approved tree list.

A motion for the city to remove tree and grind stump and the homeowner to replace tree was made by Phyllis Wilson seconded by Kira Propst. Motion carried 3-0.

Third agenda item discussed was the request to remove tree located at 727 W. Vine. The maple tree is on the east side of the property line and is visibly hollow from the base of the trunk to the top. Potential danger due to several cars and homes close by.

Motion for the city to remove the tree and grind the stump was made by Phyllis Wilson and seconded by Kira Propst. Motion carried 3-0.

In other matters, Barb Grabner-Kerns will call Ameren to inquire about grants to add money to the tree budget for tree removals. Board was in favor.

Dean Long had a request to bring before the board. He has a maple tree located at 315 N Pershing Ave. that he would like the city to trim. He stated that he had discussed it with Superintendent Wiseman and wanted to bring it to the tree board's attention for approval. The board discussed and stated they would pass on his request to the Street and Sewer Committee.

No other matters were brought before the board.
